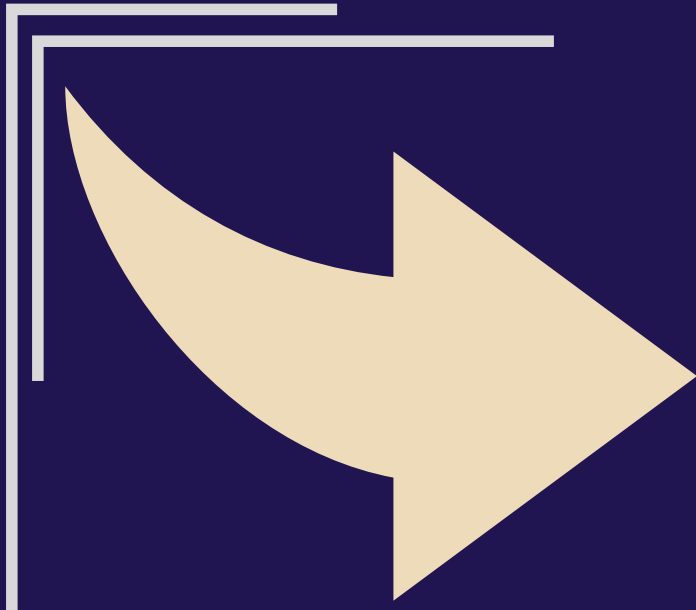

FLOATING RATE

One Year Note	3.000%	(3.03% APY)
Three Year Note	3.250%	(3.29% APY)
Five Year Note	3.500%	(3.55% APY)
Flex Savings	1.000%	(1.00% APY)
Rainy Day Fund**	1.250%	(1.26% APY)
